Rules Governing the award of Research Scholarships

1. GENERAL:

- a. The Aspee Agricultural Research & Development Foundation (hereinafter referred to as the Foundation) provides scholarship for Agricultural research in the following areas.
 - Post Harvest Technology for Fruits, Vegetables & Flowers
 - Medicinal Plants for Commercial Application
 - Pesticide Application Technique & efficiency
 - Export Oriented Horticulture
 - Plant Biotechnology
 - Organic Farming
- b. The Research Projects should be executed through Investigator who are.
 - i. M.Sc (Agri) /M.Tech. (Agril. Engg.) students
 - ii. Ph. D. students
 - iii. Qualified and experienced research personnel.
- c. The Principal Investigators (P. I.) from Agricultural Universities / Institutes can prepare Research Projects for submission to the Foundation to be carried out by an Investigator. He must forward the application form through Head of the Department / Principal / Dean or Registrar of the University.
- d. The Research Projects should be time bound, result oriented and should be of practical utility.
- e. The Research Project proposals complete in all respects should reach the office of the Foundation by Registered Post by the due date. Incomplete proposals will not be considered.
- f. The Research Projects received will be scrutinized by the Selection Committee and its decision will be final. The Foundation will not enter into any correspondence in case of rejected project proposals.
- g. The Foundation will pay traveling expenses to the Principal Investigators if called to Mumbai for discussion.
- h. The scholarship will be governed by the rules in force from time to time. The candidate will not be allowed to hold another appointment and receive another payment.
- i. The Investigator shall submit to the Foundation Quarterly Progress Report for the quarters, January to March, April to June, July to September and October to December within a month after the end of each quarter. The scholarship will be released only after the receipt of a satisfactory quarterly progress report duly certified by the Principal Investigator.

2. ELIGIBILITY:

- a. Only those students of Indian Nationality as defined in the constitution of India or students domiciled in India are eligible.
- b. The P. I. who has guided postgraduate students or executed successfully research projects are eligible to submit Research Projects.
- c. The Research Projects should be executed by any one of the following categories of Investigator.
 - i) M. Sc. (Agri.) or M. Tech (Agril. Engg.) students.
 - ii) Ph. D. students
 - iii) In an exceptional case, by a qualified and experienced research scientist.
- d. The bio data of the P. I. and Investigator should also be submitted before the due date in the prescribed form. The bio data of Investigator should be countersigned by the P. I.
- e. **In case the major guide feels that the research work implemented by the students deserves to be carried forward for one year more though another P.G. student, the guide may is free to do so without changing the experimental design and methodology so that there will be a continuity in the research programme to obtain publishable results. The financial assistance by way of scholarship will be given to the students so selected for the next year.**
- f. The projects proposals must be in the format suggested by the Foundation and must contain all the details asked for.

- g. The commencement of project work in case of research scientist and admission in case of postgraduate student should not have taken place 6 month before submission of project proposal.
- h. The eligible upper limits of age in case of M.Sc. (Agri) & M.Tech (Agril. Engg) is 30 years and in case of Ph. D is 40 years.

3 VALUE & DURATION:

- a. For projects executed by M.Sc (Agri)/ M. Tech (Agril. Engg) students.
Rs. 1,500/-p.m. scholarship from the date of selection project till the completion of the project or for a period of 24 months from the date of selection whichever is less.
- b. For projects executed by Ph. D. students.
Rs. 1,800/- p.m. scholarship from the date of selection of the project till the completion of the project or for a period of 36 months from the date of selection whichever is less.
- c. The Foundation will pay an honorarium of Rs. 2,000/- to the Principal Investigator with the permission of the concerned Head of the Department or Institute, after receipt of two copies of thesis of the Investigator in the Foundation office.

4 TERMINATION OF THE SCHOLARSHIP:

- a. The scholarship will be treated as prematurely terminated under any of the following situations:
 - i) The Investigator relinquishes the scholarship offered by the Foundation due to any reason.
 - ii) The Investigator leaves the research work before its completion.
 - iii) The Investigator accepts other financial assistance or salary except in case of Research Scientist.
 - iv) Non-submission of quarterly progress reports.
- b. In case of premature termination as above the scholar has to refund the entire amount to the Foundation received by him / her till time of termination.
- c. The scholarship tenure will also be treated as terminated on the successful completion of the work or at the end of 24 months / 36 months (as the case be) from the date of selection whichever is early.

5 THESIS

- a. The receipt of financial assistance from the Foundation should be suitably acknowledged in the thesis giving its full name as **“Aspee Agricultural Research and Development Foundation” Malad (W), Mumbai - 400 064.**
- b. Two copies of the thesis are required to be sent to the Foundation after its approval.

IMPORTANT NOTE

- 1. Project proposal should be as per the enclosed format.
 - 2. Two copies of Project Proposals including Bio data of Principal Investigator and Investigator are required to be sent to the Foundation.
 - 3. Limit the Project Proposal to 2000 words.
